**PROCEEDINGS OF THE 19TH ANNUAL GENERAL MEETING OF MUTHOOT
FINANCE LIMITED HELD ON THURSDAY, 29TH SEPTEMBER, 2016**

The 19th Annual General Meeting (AGM) of Muthoot Finance Limited (the Company) was held on Thursday, 29th September, 2016 at 10.30 a.m. at Kerala Fine Arts Society Hall, Fine Arts Avenue, Fore Shore Road, Kochi, Kerala - 682 016.

The Meeting commenced with a silent prayer. Mr. Maxin James, Company Secretary welcomed the members and informed them about the e-voting conducted from 26.09.2016 to 28.09.2016 (both days inclusive) on the proposed resolution in the Notice of Annual General Meeting. Thereafter he requested the Chairman to preside over the meeting.

Mr. M. G. George Muthoot, Chairman of the Company presided over the 19th Annual General Meeting. The requisite quorum being present, Chairman called the meeting to order. All the Directors except Ms. Pamela Anna Mathew, Independent Director was present for the meeting. Chairman thereafter introduced the members sitting on the Dias to the shareholders.

After obtaining the consent of the members present, the notice sent to members calling the Annual General Meeting along with Board's report was taken as read.

Chairman addressed the members and appraised them about the performance of the company during the financial year 2015-16, and the general economic scenario of the country, regulatory changes which affected the Company during Financial Year and also the prospects and future course of actions planned for the Company. He also informed the members about the investment made by the Company in Muthoot Homefin (India) Ltd., the acquisition of M/s. Belstar Investment and Finance Private Limited and M/s. Muthoot Insurance Brokers Pvt. Ltd. and about the enhancement of shareholding in the subsidiary company M/s. Asia Asset Finance PLC. He further informed the shareholders about the upward revision in credit rating of the Company by CRISIL and ICRA, India's leading credit rating agencies from 'AA- / Stable' to 'AA/ Stable'.
